- **Sarah Morris-Probert, President**

Sarah is currently serving a term that expires at the 2020 AGM.

- **Sasha Djurdjevic, Treasurer**

Sasha is currently serving a term that expires at the 2020 AGM.

- **Dina Genkin, Director**

Dina is currently serving a term that expires at the 2020 AGM.

- **Jeff Scott, Director**

Jeff is currently serving a term that expires at the 2020 AGM.



**B)** The following is the list of Directors who have terms expiring at the 2019 AGM but have agreed to put their name forward for an additional term to 2021:

- **Kay Fulford, Director**
